

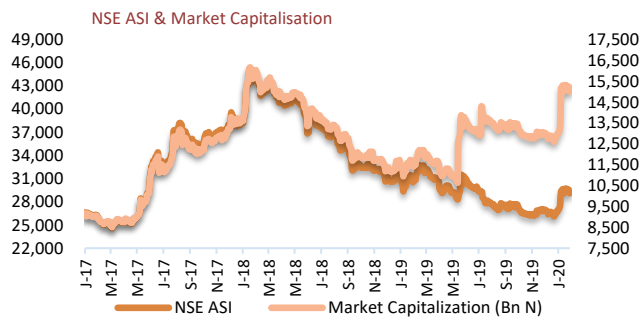


# Cowry Daily Market Insight 27 May 2020

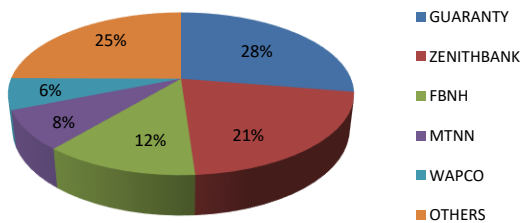

Domestic Equities Market Rises by 0.07% amid Sustained Bullish Activity; NIBOR Rises for All Tenor Buckets amid Sustained Liquidity Squeeze.....

The Local Bourse All Share Index (ASI) rose marginally by 0.07% amid sustained bullish activity even as the Exchange recorded 31 gainers against 11 losers. Hence, the year to date loss of the NSE ASI moderated to 6.03%, Specifically, Banking and Consumer goods stocks were the toast of investors today as share prices of GUARANTY, ZENITHBANK and NB rose by 4.63%, 5.60% and 10% respectively, lifting their respective indices rose by 5.36% and 3.09%. However, the NSE Insurance, NSE Industrial and NSE oil/gas indices tanked by 0.56%, 0.34% and 1.98%. Meanwhile, the value of stocks traded rose by 94.04% to 5.5 billion as 1.5 billion and 1.1 billion worth of Guaranty and ZenithBank shares exchanged hands today. Elsewhere, NIBOR rose for all tenor buckets amid sustained liquidity squeeze; however, NITTY moved in mixed directions. In the OTC bonds market, the values of FGN bonds were flattish for all maturities; however, FGN Eurobond rose for most maturities.
