



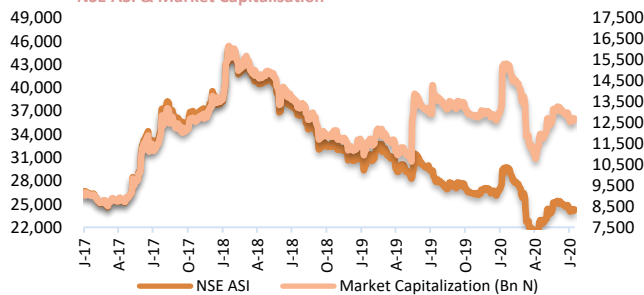

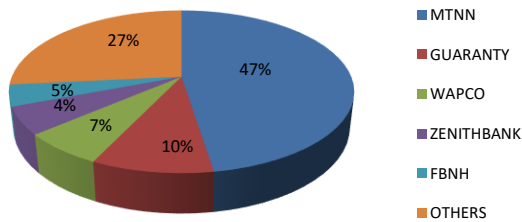
Nigerian Equities Market Index Falls by 0.54% amid Renewed Bearish Activity; NIBOR Declines for All Tenor Buckets amid Sustained Liquidity Ease...

The Lagos bourse All Share Index (ASI) declined by 0.54% amid renewed profit taking activity even as the Exchange printed 17 (losers) as against 14 (gainers) at the close of trading session. Hence, the year to date loss of the NSE ASI worsened to 8.16%. Specifically, TOTAL and SEPLAT suffered the worst hit as their respective share prices moderated by 9.95% and 9.82% amid investor's sell-off; hence, the NSE Oil/Gas index plummeted by 5.20%. Similarly, the NSE Banking and NSE Consumer Goods indices tanked by 0.45% and 0.13% respectively. On the Positive side, the NSE Insurance index rose by 0.43% while the NSE Industrial index closed flat. Meanwhile, the volume and value of stocks traded dipped by 11.53% and 17.08% to 0.40 billion units and N1.97 billion respectively. Elsewhere, NIBOR declined for all tenor buckets amid sustained liquidity ease; however, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, FGN Eurobond rose for most maturities tracked amid demand pressure.
