



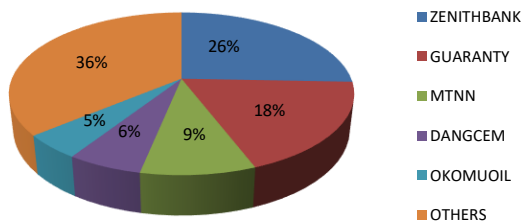
Local Equities Market Index Advances by 0.38% amid Sustained Bullish Activity; NIBOR Moves in Mixed Directions Across Tenor Buckets...

The Nigerian bourse sustained its bullish momentum as its All Share Index (ASI) revved by 0.38% to close at 25,236.97 points, albeit the numbers of losers (18) outweighed the number of gainers (13) at the close of the trading session. Hence, the year to date loss of the NSE ASI moderated to 5.9%. Specifically, Tickers such as NB, MTNN and ACCESS appreciated by 5.88%, 0.84% and 1.56% respectively amid investors demand. Similarly, most of the sub-sectors tracked closed in positive territory save the NSE Industrial index which declined by 0.12%. The NSE Banking, NSE Insurance, NSE Consumer Goods and NSE Oil/Gas indices rose by 0.03%, 2.61%, 1.46% and 0.31% respectively. Meanwhile, the total volume of stocks traded rose by 25.97% to 0.25 billion units while the value of stocks traded plunged by 56.18% to N1.6 billion. Elsewhere, NIBOR moved in mixed directions across tenor buckets; however, NITTY declined for most maturities tracked. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; also, FGN Eurobond rose for most maturities tracked.
