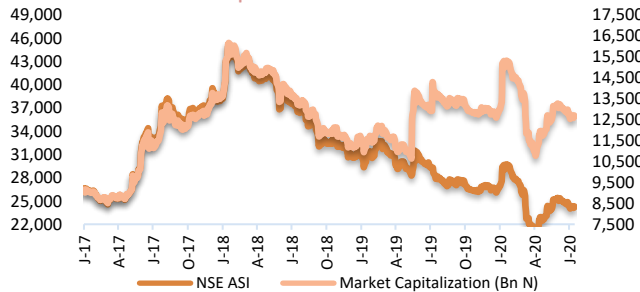




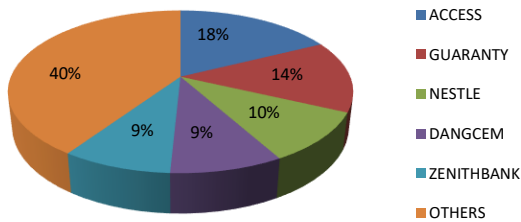
Local Bourse Index Rebounds by 0.02% amid Renewed Bullish Activity; NIBOR Moves in Mixed directions across Tenor Buckets...

The domestic equities market ended the week in positive territory as its All Share Index rose marginally by 0.02% to 25,309.37 points; albeit the number of losers (13) outweighed the gainers (12) at the close of trading session. Hence, the year to date loss of the NSE ASI eased to 5.71%. Amid renewed bullish activity, the share prices of Tickers such as CAP, GUARANTY and ACCESS advanced by 3.41%, 0.79% and 2.40% respectively. Similarly, performance across sub-sector gauges was bullish as three out of the five indices closed in green; the NSE Banking, NSE Insurance and NSE Industrial indices advanced by 0.37%, 0.62% and 0.01% respectively. However, the NSE Consumer Goods index moderated by 0.20% while NSE Oil/Gas index closed flat. Meanwhile, market activity was weak as total volume and value of stocks traded dwindled by 44.99% and 41.09% to 0.13 billion units and N0.92 billion respectively. Elsewhere, NIBOR and NITTY moved in mixed directions across tenor buckets. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; also, FGN Eurobond declined for most maturities tracked.
