The NSE ASI Advances by 0.20% on Positive Tier-1 Banks' H1 2020 Financial Results; NIBOR Rises for Most Tenor Buckets amid Sustained Liquidity Strain...

At the close of Thursday's trading session, the domestic equities market ASI further gained 0.20% to close at 25,511.02 points on sustained bargain hunting activity even as the Exchange printed 19 gainers as against 6 losers. Hence, the year to date loss of the NSE ASI moderated to 4.9%. We saw investors respond positively to the H1 2020 financial results by most Tier 1 Banks, hence, lifting the NSE Banking index by 0.46% as share prices of ZENITHBANK, GUARANTY and UBA appreciated by 1.47%, 0.19% and 0.78% respectively. Similarly, the NSE Insurance and NSE Consumer Goods indices rose by 0.50% and 0.02% respectively. On the flip side, the NSE Oil/Gas and NSE Industrial indices closed flat. Meanwhile, market activity picked up as the total volume and value of stocks traded rose by 33.88% and 33.91% to 0.23 billion units and N1.31 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid sustained liquidity strain; however, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; however, FGN Eurobond declined for most maturities tracked.
