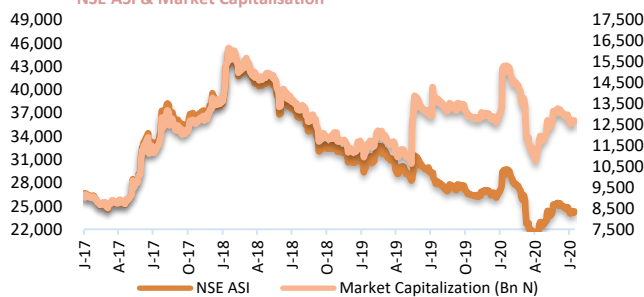




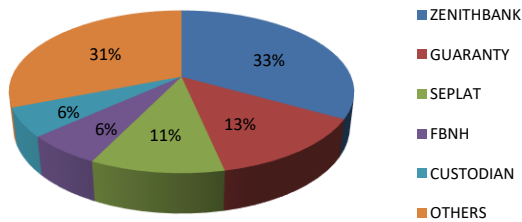
The NSE All Share Index Rebounds by 0.38% amid Renewed Bullish Activity; NIBOR Rises for Most Tenor Buckets amid Sustained Liquidity Strain...

The domestic equities market ASI rose by 0.38% to close at 25,520.97 points, following the three consecutive days of losses. Similarly, the number of gainers (22) outweighed that of the losers (12) at the close of the trading session. Hence, the year to date loss of the NSE ASI eased to 4.9%. Specifically, the NSE banking index gained 2.28% as investors took advantage of the recent declines in share prices of ZENITHBANK, GUARANTY, ACCESS and UBA; hence, their respective share prices rose by 3.35%, 1.85%, 3.85% and 1.64% respectively. Similarly, the NSE Consumer Goods and NSE Industrial indices rose by 0.08% and 0.02% respectively. On the flip side, the NSE Insurance and the NSE Oil/Gas indices moderated by 1.66% and 1.28% respectively. Elsewhere, NIBOR rose for all tenor buckets amid sustained liquidity strain; however, NITTY declined for most maturities tracked in tandem with declining stop rates at the primary auction yesterday. Stop rates for 91-Day, 181-Day and 364-Day fell to 1.1%, 1.55% and 3.05% respectively. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; also, FGN Eurobond increased for most maturities tracked.
