

The NSE All Share Index Advances by 0.05% amid Sustained Bullish Activity; NIBOR Declines for All Tenor Buckets amid Sustained Liquidity Ease... At the close of today's trading session, the domestic equities market NSE ASI rose marginally by 0.05% to 25,605.59 points amid sustained bargain hunting activity. Also, the Exchange recorded 17 gainers as against 16 losers. Hence, the year to date loss of the NSE ASI eased to 4.6%. Specifically, renewed buying interest in bellwethers such as GUARANTY, ZENITHBANK and DANGCEM lifted their respective share prices higher by 0.40%, 0.29% and 0.75%. Hence, the NSE Banking and NSE Industrial indices rose by 0.15% and 0.51% respectively. On the flip side, the NSE Insurance, NSE Consumer Goods and NSE Oil/Gas indices moderated by 0.07%, 0.50% and 0.08% respectively. Meanwhile, market activity was upbeat as the total volume and value of stocks traded increased by 20.82% and 45.73% to 0.25 billion units and N3.3 billion respectively. Elsewhere, NIBOR declined for all tenor buckets amid sustained liquidity ease; however, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds was flattish for most maturities tracked; also, FGN Eurobond moderated for most maturities tracked.
