Friday's Trading Closes Positive as NSE ASI Rebounds by 0.15% on Renewed Investor's Interest; NIBOR Declines for All Tenor Buckets amid Sustained Liquidity Ease...

The domestic equities market closed the week in positive territory as its All Share Index (ASI) rose by 0.15% to 25,572.57 points amid renewed bargain hunting activity. Also, the Exchange printed 17 gainers as against 6 losers even as share prices of bellwethers such as GUARANTY, ACCESS and UBA closed higher, rising by 0.40%, 1.57% and 0.83% respectively. Notably, performance across sub-sector gauges tracked moved in different direction as the NSE Banking and the NSE Consumer Goods increased by 0.30% and 0.59% respectively, while the NSE Oil/Gas and the NSE Industrial indices closed flat. However, the NSE Insurance moderated by 0.03%. Hence, the year to date loss of the NSE ASI fell to 4.73%. Meanwhile, market activity was weak as the total volume and value of stocks traded dwindled by 45.55% and 36.79% to 0.12 billion units and N1.3 billion respectively. Elsewhere, NIBOR declined for all tenor buckets amid renewed liquidity ease; also, NITTY moderated for most maturities tracked, save NITTY for 12 months maturity which rose by 0.03%. In the OTC bonds market, the values of FGN bonds was flattish for most maturities tracked; also, FGN Eurobond fell for most maturities tracked.
