
Local Equities Market YTD Performance Turns Positive as ASI Rises by 0.54%; NIBOR Declines for Most Tenor Buckets amid Renewed Liquidity Ease...

The domestic equities market sustained its bullish momentum throughout the trading week as its All Share Index further gained 0.54% at the end of the trading session today. Consequently, the year to date loss of the NSE ASI turned positive, rising by 0.52%. Also, the Exchange recorded 18 gainers as against 14 losers as buy interest in the shares of bellwethers such as DANGCEM, MTNN, WAPCO and ZENITHBANK lifted their respective prices higher by 0.77%, 0.78%, 1% and 0.84%. Similarly, performance was bullish across sub-sector gauges tracked as most of the indices closed in green except for the NSE Insurance index which fell by 1.70%. The NSE Banking, NSE Consumer Goods, NSE oil/Gas and the NSE Industrial indices rose by 1.99%, 0.32%, 0.15% and 0.45% respectively. However, market activity waned as the total volume and value of stocks traded declined by 19.34% and 28.90% to 0.36 billion units and N2.8 billion respectively. Elsewhere, NIBOR and NITTY fell for most tenor buckets amid sustained liquidity ease. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, FGN rose moderated for most maturities tracked.
