



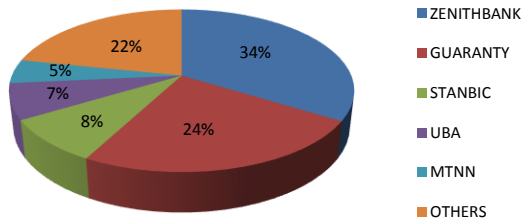
## The Domestic Market Index Closes Flat; NIBOR Rises for most Tenor Buckets amid Renewed Liquidity Strain...

At the end of Wednesday's trading session, the local equities market closed flat at 28,344.04 points despite the Exchange printing 14 gainers as against 11 losers. Hence, the year to date gain of the NSE ASI remain unchanged at 5.5%. Notably, we saw Tickers such as GUINNESS, GUARANTY, WAPCO and ETI closed higher by 3.33%, 1.52%, 2.06% and 1.16% respectively amid investors' demand. However, performance across sub-sector gauges tracked failed to mirror the market performance as four out of five indices tracked closed in green except the NSE Oil/Gas which fell by 0.17%. The NSE Banking, NSE Insurance, NSE Consumer Goods and NSE Industrial indices advanced by 0.40%, 0.60%, 0.21% and 0.15% respectively. Meanwhile, market activity was weak as the total volume and value of stocks traded declined by 59.24% and 37.46% to 0.21 billion unit and N3.1 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; however, NITTY moderated for most maturities tracked. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; also, FGN Eurobond moderated for all maturities tracked.
