



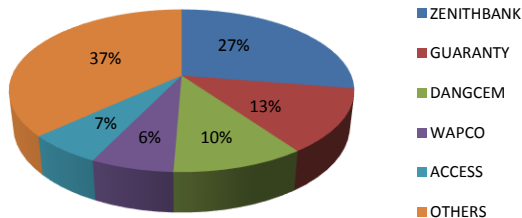
The Domestic Market Index Sheds 0.86% amid Renewed Profit Taking Activity; NIBOR falls for most Tenor Buckets amid Sustained Liquidity Ease...

The local Bourse closed the week in negative territory as its All Share Index (ASI) moderated by 0.86% to close at 35,037.46 points. Hence, the year to date gain of the NSE ASI fell to 30.53%. Similarly, the Exchange recorded 26 gainers as against 37 losers as investors sold part of their holdings in bellwethers to book profit following the recent stock price increase. Specifically, share prices of Tickers such as MTNN, GUARANTY, ZENITHBANK and UBA declined by 4.32%, 4.71%, 3.55% and 5.64% respectively. Of the five indices tracked, three closed in red; the NSE Banking, NSE Insurance and the NSE Oil/Gas indices moderated by 5.35%, 3.20% and 0.31% respectively. On the positive side, the NSE Consumer Goods and the NSE Industrial indices rose by 0.07% and 0.63% respectively. Meanwhile, the total volume rose by 4.27% to 1.24 billion units; however, the value of stocks fell by 6.38% to N16.28 billion. Elsewhere, NIBOR falls for most tenor buckets amid sustained liquidity ease; however, NITTY rose for all maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, FGN Eurobond moderated for all maturities tracked.
