
Local Equities Market Index Falls by 0.24% amid Sustained Profit Taking Activity; NIBOR Closes Flat for most Tenor Buckets...

The domestic bourse closed the week on a bearish note as its ASI sheds 0.24% to close at 41,001.99 points. Consequently, the year-to-date gain of the NSE ASI moderated to 1.81% even as the number of losers (33) outnumbered that of the gainers (21). Specifically, we saw continued sell-off in Insurance stocks and large-cap stocks as investors book profit. Hence, share prices of AIICO, MANSARD, WAPCO and ACCESS declined by 9.72%, 7.25%, 6.98% and 1.08% respectively. Of the five indices tracked, four closed in red zone save the NSE Consumer Goods which rose by 0.06%. The NSE Insurance index led the laggards by 7.93%, followed by the NSE Industrial, NSE Oil/Gas and the NSE Banking indices by 0.50%, 0.29%, 0.17% respectively. Meanwhile, activity in the market was also bearish as total deals, volume and value of stocks traded declined by 22.11%, 47.26% and 20.72% to 5,767 deals, 0.59 billion units and N5.0 billion respectively. Elsewhere, NIBOR closed flat for most tenor bucket; albeit, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, the value of FGN Eurobond dwindled for maturities tracked.
