
The Local Equities Market Index Falls by 0.18% amid Sustained Bearish Activity; NIBOR Closes Flat for most Tenor Buckets...

The domestic bourse closed the week southwards as its All Share Index (ASI) moderated by 0.51% to close at 41,709.09 points amid sell-offs on Large-cap stocks. Hence, the year-to-date gain of the NSE ASI moderated to 3.57% even as the number of losers (37) outweighed that of the gainers (14). Notably, the 362-day OMO bills auctioned yesterday closed at a rate of 10.10% which poses a signal to investors about yields reversing upwards; hence continued sell-off in the equities space. Specifically, blue-chip stocks such as WAPCO, MTNN and ZENITHBANK moderated by 3.62%, 0.55% and 2.80% respectively. Of the five indices tracked, four closed in red; the NSE Insurance, NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices fell by 1.03%, 0.97%, 0.13% and 0.26% respectively. However, the NSE Banking index rose by 1.36%. Meanwhile, activity in the market was weak as total volume and value of stocks traded declined by 23.39% and 30.09% to 0.48 billion units and N5.5 respectively. Elsewhere, NIBOR closed flat for most tenor bucket; albeit, NITTY moderated for most maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, the value of FGN Eurobond rose for all maturities tracked amid demand pressure.
