Domestic Equities Index Dips by 0.06% amid Sustained Bear Bashing; NIBOR Rises for all Tenor Buckets amid Sustained Liquidity Strain...

The local bourse closed the week southwards as the All-Share Index (ASI) moderated by 0.06% to 40,186.70 points even as the number of losers (20) outnumbered the gainers (18). Consequently, the year-to-date gain of the NSE ASI turned negative to -0.2%. Notably, blue chip stocks such as SEPLAT, WAPCO and FBNH continued to trek southwards as their respective share prices fell by 3.46%, 2.15% and 0.68% amid investors sell-offs. Of the five indices tracked, three closed in red territory: the NSE Insurance, NSE Oil/Gas and NSE Industrial indices declined by 1.83%, 1.82% and 0.15% respectively. On the positive side, the NSE Banking and NSE Consumer Goods indices rose by 1.95% and 0.08% respectively. Meanwhile, trading activity was weak as total deals, volume and value of stocks traded fell by 11.65%, 27.80% and 38.84% to 4,393 deals, 0.30 billion units and N2.9 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid sustained liquidity strain; also, NITTY rose for most maturities tracked amid sell pressure. In the OTC bonds market, the values of plain vanilla FGN bonds moderated for most maturities tracked; also, the value of FGN Eurobonds fell for most maturities tracked.
