Local Equities Market Sustains Bullish Momentum as the ASI Increases by 0.43%; NIBOR Falls for most Tenor Buckets amid Sustained Liquidity Ease...

At the end of Tuesday's trading session, the domestic stock market index advanced by 0.43% to close at 39,015.58 points amid sustained bullish activity even as the Exchange recorded more gainers (24) than losers (10). Consequently, the year-to-date loss of the NSE ASI fell to -3.11%. Specifically, buying interest in blue chip stocks such as MTNN, ZENITHBANK and GUARANTY increased their share prices by 1.04%, 2.77% and 1.69% respectively. Breakdown across subsector gauges tracked indicated that three out of the five indices tracked closed in green; the NSE Banking, NSE Insurance and the NSE Consumer Goods indices rose by 1.80%, 1.10% and 0.40% respectively. However, the NSE Oil/Gas index moderated by 0.03% while the NSE Industrial index closed flat. Meanwhile, trading activity mellowed as total deals, volume and value of stocks traded moderated by 2.78%, 33.34% and 91.58% to 4,203 deals, 0.33 billion units and N2.7 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid sustained liquidity ease; also, NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, the value of FGN Eurobond fell for all maturities tracked.
