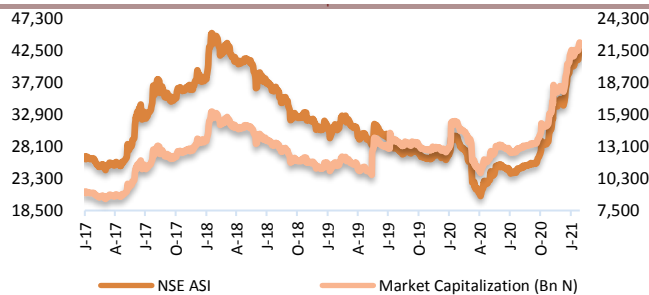


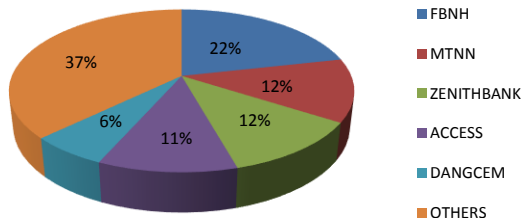
## Domestic Equities Market Index Gains 0.96% amid Sustained Bullish Activity; NIBOR Rises for all Tenor Buckets amid Sustained Liquidity Strain...

At the close of Friday's trading session, the domestic stock market index increased by 0.96% to settle at 39,834.42 points amid sustained bargain hunting activity even as the Exchange printed equal number (22 apiece) of gainers and losers. Hence, the year-to-date loss of the NSE ASI fell to -1.08%. Notably, positive release of Q1 2021 financial results by corporates spurred buying activity in the market. Hence, share prices of heavy weight stocks such as BUACEMENT, MTNN, NB, ZENITHBANK and ACCESS increased by 7.15%, 1.98%, 1.48%, 0.45% and 1.39% respectively. Of the five indices tracked, four closed in green zone save for the NSE Oil/Gas index which fell by 0.51%. The NSE Banking, NSE Insurance, NSE Consumer Goods and the NSE Industrial indices rose by 0.11%, 0.86%, 0.29% and 2.37% respectively. Meanwhile, trading activity picked up as total deals, volume and value of stocks traded rose by 26.64%, 42.42% and 72.59% to 4,317 deals, 0.31 billion units and N2.9 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid sustained liquidity strain; however, NITTY fell for all maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, the value of FGN Eurobond fell for most maturities tracked.
