
Domestic Equities Market Index Rises by 0.15% on Renewed Positive Sentiment; NITTY Falls for all Maturities amid Demand Pressure...

At the end of Wednesday's trade, the local bourse All-Share Index advanced by 0.15% to close at 38,564.70 points even as the Exchange recorded more gainers (27) than losers (21). Consequently, the year-to-date loss of the NSE ASI fell to -4.23%. Notably, bellwether stocks such as SEPLAT, MTNN, UBA and ZENITHBANK enjoyed investor's patronage as their respective share prices increased by 1.45%, 1.23%, 2.11% and 0.21%. However, sectorial performance didn't mirror overall market performance as most of the indices tracked closed southwards; the NSE Banking, NSE Insurance and the NSE Industrial indices fell by 0.32%, 0.51% and 0.03% respectively. On the positive side, the NSE Consumer Goods and the NSE Oil/Gas indices fell by 0.18% and 0.92% respectively. Meanwhile, trading activity was weak as total deals and value of stock traded fell by 0.34% and 23.02% to 4,387 deals and N2.8 billion respectively. Elsewhere, NIBOR moved in mixed directions across tenor buckets; albeit, NITTY fell for all maturities tracked amid demand pressure even as inflation lowered for the second consecutive time. In the OTC bonds market, the values of FGN bonds moved in mixed directions for most maturities tracked; albeit, the value of FGN Eurobond fell for all maturities tracked.
