

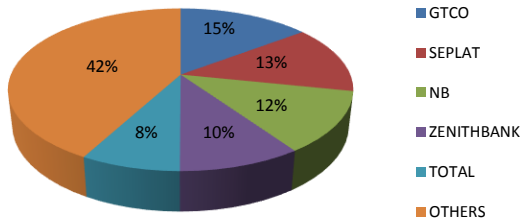
Equities Market Index Rebounds by 0.15% amid Renewed Bullish Activity; NIBOR Falls for all Tenor Bucket amid Financial Liquidity Ease...

At the end of Tuesday's trade, the domestic bourse Index increased by 0.15% to close at 37,640.75 points amid renewed positive investors' sentiment. Also, the Exchange printed more gainers (28) than losers (18). Consequently, the year-to-date loss of the NSE ASI fell to 6.53%. Notably, tickers such as OKOMUOIL, CADBURY, DANGSUGAR, ZENITHBANK and FBNH were the toast of investors today as their respective share prices rose by 4.27%, 9.62%, 4.17%, 0.42% and 1.39% respectively. Of the five indices tracked, three closed in green zone; the NSE Banking, NSE Insurance and the NSE Consumer Goods indices advanced by 0.25%, 2.22% and 0.29% respectively. On the flip side, the NSE Oil/Gas index fell by 0.86% while the NSE Industrial index closed flat. Meanwhile, trading activity was mixed as total deals and volume of stock traded rose by 3.26% and 40.07% to 3,678 deals and 0.22 billion units respectively; however, value of stocks traded fell by 20.57% to N2.7 billion. Elsewhere, NIBOR moderated for most tenor buckets amid financial liquidity ease; albeit, NITTY rose for most maturities tracked amid sell pressure. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; albeit, the value of FGN Eurobond fell for all maturities tracked.
