

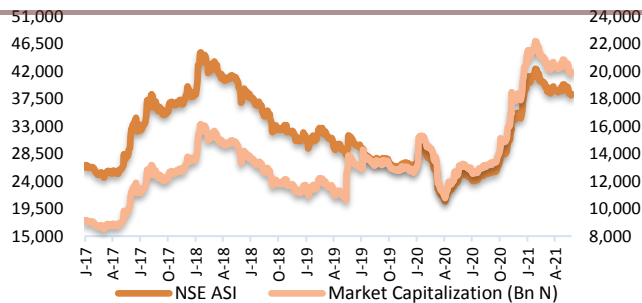

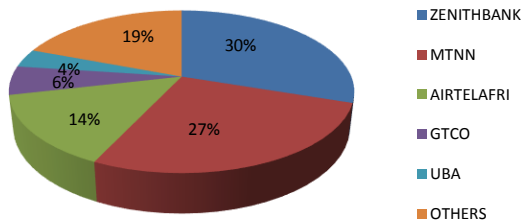
The domestic bourse All-share Index Declines by 0.36% amid Sustained Bearish Sentiment; NIBOR Rises for most Tenor Bucket amid Financial Liquidity Strain...

The domestic bourse index moderated by 0.36% to settle at 37,857.89 points amid sustained bearish activity; albeit the Exchange printed more gainers (16) than losers (13) at the close of trading session. Specifically, bearish proceedings dominated the market as sell pressure on heavy weighted stocks dragged the index lower. Hence, the year-to-date loss of the local bourse worsened to 5.99%. Tickers such as MTNN, BUACEMENT, ZENITHBANK and WAPCO contracted by 0.61%, 0.70%, 2.20% and 1.15% respectively. Of the five indices tracked, four closed in red zone save the NSE Oil/Gas index which rose by 0.05%. The NSE Banking, the NSE Insurance, NSE Consumer Goods and the NSE Industrial indices declined by 1%, 0.03%, 0.40% and 0.35% respectively. Meanwhile, trading activity was mixed as total deals and volume of stock traded rose by 5.18% and 6.74% to 4,017 deals and 0.28 billion units respectively; albeit the value of stocks traded fell by 22.58% to N1.8 billion. Elsewhere, NIBOR rose for most tenor buckets amid financial liquidity strain; however, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across most maturities tracked; however, the value of FGN Eurobond rose for all maturities tracked.
