
Equities Market Sustains Bullish Trend as All Share Index Rises by 0.03%; NIBOR Falls for most Tenor Buckets amid Financial Liquidity Ease...

The domestic bourse index advanced by 0.03% to 38,927.83 points amid sustained bargain hunting activities; albeit the numbers of losers (19) outweighed that of the gainers (16) at the close of trading session. Hence, the year-to-date loss of the local bourse declined to 3.33%. Specifically, medium and large cap stocks such as PRESCO, FCMB, WAPCO and ZENITHBANK were the toast of investors today as their respective share prices rose by 3.71%, 2%, 0.46% and 0.41%. However, sectorial performance remained weak as three out of the five indices tracked closed southwards; the NSE Insurance, NSE Consumer Goods and the NSE Oil & Gas indices moderated by 0.18%, 0.04% and 0.63% respectively. On the positive side, the NSE Banking and the NSE Industrial indices rose by 0.56% and 0.04% respectively. Meanwhile, trading activity was weak as total deals, volume and value of stocks traded fell by 26.14%, 10.87% and 49.84% to 3,435 deals, 0.26 billion unit and N1.06 billion respectively. Elsewhere, NIBOR fell for most maturities tracked amid financial liquidity ease; albeit, NITTY increased for most maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked while the value of FGN Eurobond fell for most maturities tracked.
