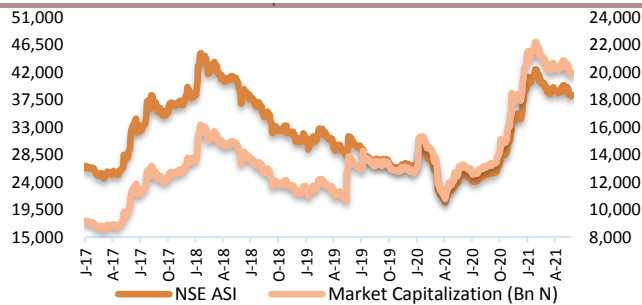


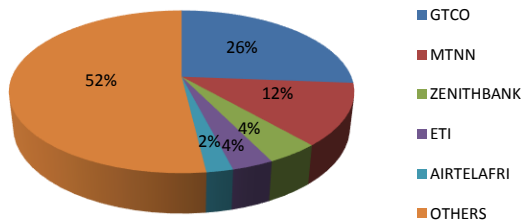
Local Equities Market Index Advances by 0.69% amid Sustained Bullish Activity; NIBOR Rises for all Tenor Buckets amid Financial Liquidity Strain...

The domestic bourse sustained its bullish trend as its All-share index rose by 0.69% to settle at 39,448.46 points even as the number of gainers (20) outweighed that of the losers (15) at the close of the trading session. Consequently, the year-to-date loss of the local bourse moderated to 2.04%. Specifically, blue-chip stocks such as AIRTELAFRI, GTCO and ZENITHBANK enjoyed investors' patronage as their respective share prices inched higher by 4.90%, 0.36% and 0.41%. Of the five indices tracked, three closed northwards; the NSE Banking, NSE Insurance and the NSE Oil/Gas indices rose by 0.45%, 0.01% and 0.08% respectively. However, the NSE Consumer Goods and the NSE Industrial indices fell by 0.02% and 0.01%. Meanwhile, trading activity was positive as total deals, volume and value of stocks traded fell by 13.51%, 61.77% and 47.53% to 3,599 deals, 0.18 billion units and N2.08 respectively. Elsewhere, NIBOR rose for most maturities tracked amid financial liquidity strain; albeit, NITTY moved in mixed directions for most maturities tracked even as stop rate for 364 days fell further to 7.35% (from 8.2%). Stop rate for 91-Day and 182-Day remained flattish. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked while the value of FGN Eurobond fell for all maturities tracked.
