

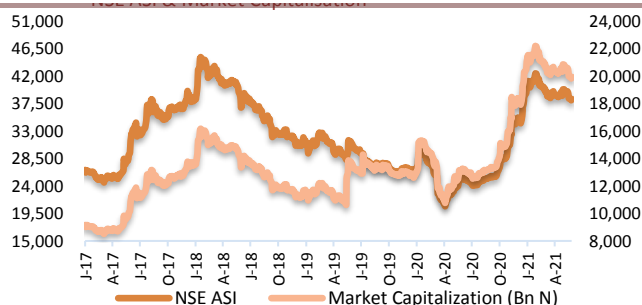

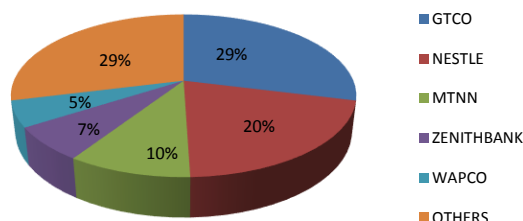

Domestic Equities Market Index Declines by 0.12% amid Sustained Profit Taking Activity; NIBOR Rises for most Tenor Buckets amid Financial Liquidity Strain...

The domestic bourse index shed by 0.12% to settle at 39,434.69 points amid sustained bearish activity; albeit the Exchange recorded more gainers (21) than losers (11) at the close of Monday's trading session. Consequently, the year-to-date loss of the local bourse rose to 2.07%. Specifically, profit taking on mid and large cap stocks such as WAPCO, PZ, GTCO, ETERNA and FLOURMILL lowered their respective share prices by 5.29%, 4.71%, 0.71%, 2.36% and 0.34%. Sectorial performance was weak as four out of the five indices tracked closed southwards; the NSE Banking, NSE Consumer Goods, NSE Oil/Gas and NSE Industrial indices fell by 0.07%, 0.12%, 0.14% and 0.32% respectively. On the positive side, the NSE Insurance index rose by 0.37%. Meanwhile, trading activity was weak as total deals, volume and value of stocks traded fell by 1.82%, 24.68% and 36.26% to 3,939 deals, 0.21 billion units and N2.02 billion respectively. Elsewhere, NIBOR rose for most tenor buckets tracked amid financial system liquidity ease; however, NITTY moved in mixed directions for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked. Elsewhere, the value of FGN Eurobond rose for most maturities tracked.
