

Nigerian Exchange Sees Renewed Bearish Activity; NIBOR Rises for most Tenor Bucket amid Financial Liquidity Strain...

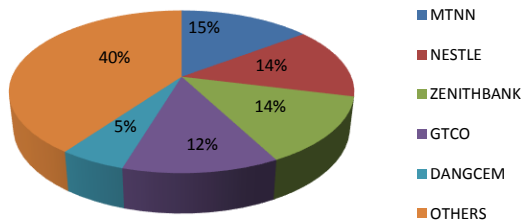
Stocks fell by 0.03% amid renewed profit taking activity as Exchange printed more losers (19) than gainers (17) at the close of Wednesday's trading session. Consequently, the year-to-date loss of the local bourse rose to 2.03%. Notably, profit taking on tickers such as DANGSUGAR, GTCO, ZENITHBANK, FBNH and ETI decreased their respective share prices by 2.78%, 0.71%, 0.41%, 0.67% and 0.92%. Of all the indices tracked, four out of the five indices tracked closed southwards; the NSE Banking, NSE Insurance, NSE Consumer Goods and NSE Industrial indices declined by 0.12%, 0.53%, 0.14% and 0.10% respectively. On the flip side, the NSE Industrial index closed flat. Meanwhile, trading activity was mixed as total volume of stocks traded rose by 0.77% to 0.19 billion units while the value of stocks traded fell by 27.33% to N1.05 billion respectively. Elsewhere, NIBOR rose for most tenor buckets tracked; also, NITTY rose for most maturities tracked amid sell pressure. In the OTC bonds market, the values of FGN bonds rose for all maturities tracked. Elsewhere, the value of FGN Eurobond rose for all maturities tracked.
