

Nigerian Exchange Rebounds by 0.07% as Q2 2021 GDP Rises by 5.01%; NIBOR Falls for most Tenor Bucket amid Financial Liquidity Ease...

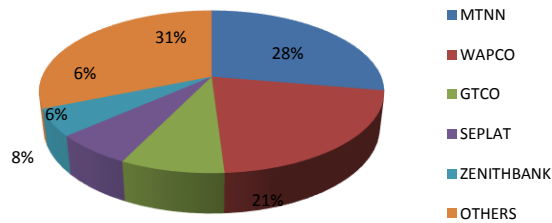
At the close of Thursday's trading session, the domestic bourse index increased by 0.07% to settle at 39,477.18 points amid renewed positive sentiment which may have been stimulated by the 5.01% y-o-y rise in Q2 2021 GDP. Consequently, the year-to-date loss of the local bourse fell to 1.97%. Notably, the bulls (23) outnumbered the bears (12) as investors hunted for bargain in small and large cap stocks. Share prices of ETERNA, GLAXOSMITH, PRESCO and AIICO expanded by 9.97%, 7.94%, 0.55% and 8.42% respectively. Of all the indices tracked, three out of the five indices closed in green zone; the NSE Banking, NSE Insurance and the NSE Oil/Gas indices rose by 0.09%, 2.33% and 0.20% respectively. On the flip side, the NSE Consumer Goods and the NSE Industrial indices closed flat. Meanwhile, trading activity was mixed as total deals and volume of stocks traded fell by 7.37% and 6.05% to 3,595 deals and 0.18 billion units respectively. Elsewhere, NIBOR fell for most tenor buckets tracked; albeit, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds fell for all maturities tracked. Elsewhere, the value of FGN Eurobond rose for all maturities tracked.
