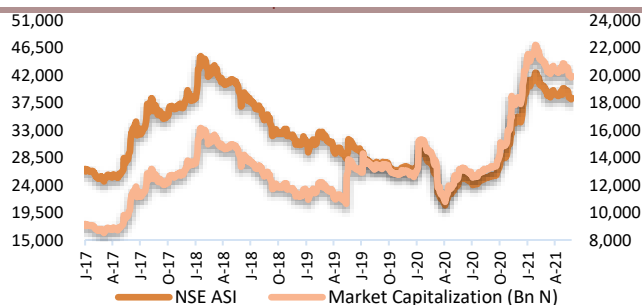


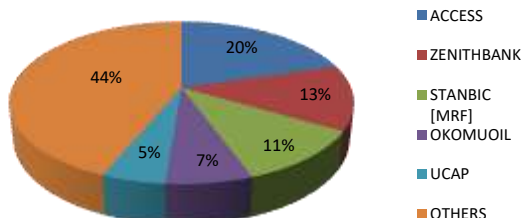


Nigerian Stock Exchange Index Falls by 0.02% amid Renewed Bearish Trend; NIBOR, NITTY Fall Further for Most Tenor Buckets amid Sustained Liquidity Ease...

The local bourse index moderated by 0.02% given the bearish sentiment witnessed on some heavy weight shares. However, the Exchange recorded more gainers (21) than losers (15) – reflective of the weight of the depressing large caps on the benchmark index. Hence, the year-to-date loss of the domestic bourse rose to 2.53%. Notably, we saw sell-offs on FLOURMILL, STANBIC and DANGSUGAR as their share prices plummeted by 4.17%, 1.38% and 2.25% respectively. Performance across the sub-sector gauges was bullish as four out of the five sub-indices tracked closed in green; the NSE Banking, NSE Insurance, NSE Oil/Gas and the Industrial indices moderated by 0.48%, 0.04%, 0.32% and 0.03% respectively. However, the NSE Consumer Goods index plunged by 0.41%. Meanwhile, trading activity was mixed as total deals and volume traded increased by 26.31% and 17.00% to 3,989 deals and 0.21 billion units respectively. However, value of stock traded fell by 19.74% to N1.38 billion. Elsewhere, NIBOR and NITTY further moved southwards for most maturities tracked amid sustained financial liquidity ease. In the OTC bonds market, the values of FGN bonds increased for most maturities tracked as yields moved lower; however, the value of FGN Eurobond decreased for most maturities tracked.
