
Domestic equities market suffered another loss today as the All-Share index (ASI) fell by 0.01% to 39,201.33 points amid sustained bearish investor's sentiment which was further aggravated by the 40basis points rise in rate on 364-day bills to 7.20%. The Central Bank of Nigeria appears to be grappling with the depreciation of Naira, especially at the parallel market where USD/Naira now trade at N535. Hence, was total number of gainers (9) fall while that of the losers rose to 21. Specifically, some of the stocks sold off by investors today include ZENITHBANK, STANBIC, WAPCO and HONYFLOUR. Thus, the year-to-date loss of the local bourse increased to 2.66%. Performance across sub-sector gauges was better as three out of the five indices tracked closed in green except for NSE Insurance and NSE Industrial indices which fell by 1.65% and 0.02% respectively. Meanwhile, given today's sell-off on bellwether stocks we saw total deals and volume of stocks traded fall by 13.97% and 1.00% to 3,523 deals and 0.35 billion units while the value of stock traded rose by 4.52% to N3.35 billion. Elsewhere, NIBOR closed higher for most maturities tracked. Also, NITTY rose for most maturities tracked in tandem with higher rate in the primary market. In the OTC bonds market, the values of FGN bonds moved in mixed directions. However, the value of FGN Eurobond decreased for most maturities tracked.
