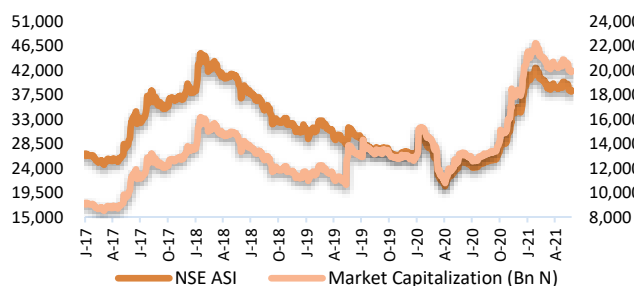


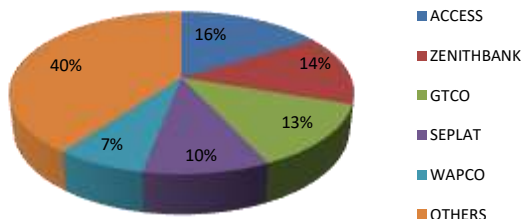


Local Equities Market Slides into Negative Territory as ASI Falls by 15bps; NIBOR Moderates for All Maturities amid Financial Liquidity Strain...

The domestic stock market All-Share Index fell by 0.15% to 38,911.31 points amid renewed profit taking activity, particularly on WAPCO, ETERNA, INTBREW, and HONYFLOUR shares. Hence, the year-to-date loss of the local bourse increased to 3.38%. Performance for most sub-sectors was bearish as four out of the five sub-indices closed negative – the NSE Banking, the NSE Consumer Goods, the NSE Oil/Gas and the NSE Industrial indices declined by 0.28%, 0.36%, 0.57% and 0.14% respectively. However, the NSE Insurance index rose by 0.47%. Meanwhile, market activity was weak as investors decided to stay on the side lines, hence the deals, volume and value of stock traded decreased by 3.80%, 7.92% and 52.00% respectively to 2,962 deals, 0.13 billion units and N1.43 billion respectively. Elsewhere, NIBOR slid lower for all maturities tracked amid renewed financial system liquidity ease. However, NITTY moved in mixed directions across maturities tracked. At the last auction, CBN surprisingly left 364-day T-bill rate unchanged at 7.20% which appears to be against market expectations of higher rate – hence dousing the sell pressure in the secondary market. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked. However, the value of FGN Eurobond fell for all maturities tracked amid renewed bearish sentiment.
