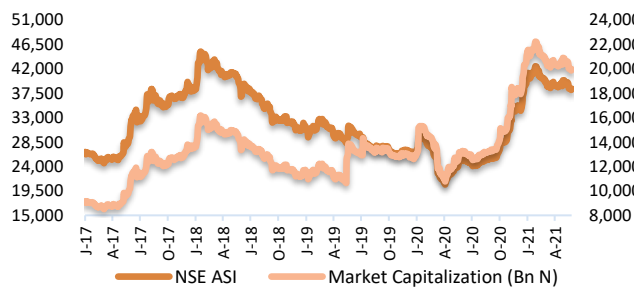


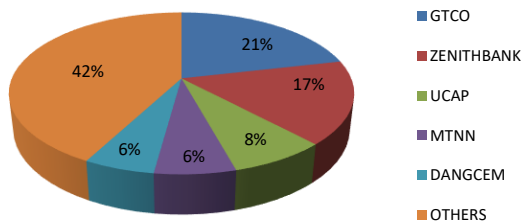
## Nigerian Stock Exchange All-Share Index Rises by 0.06% amid Renewed Buy Interest; Tight Liquidity in the Financial System Sends NIBOR Northward...

The domestic bourse All-Share Index increased by 0.06% to recover to 38,874.13 points amid renewed positive sentiment, especially on GTCO, FLOURMILL and PZ shares. Amid bargain hunting activity, the Exchange printed a higher number of losers (16) than gainers (12). Hence, the year-to-date loss of the local bourse lowered to 3.47%. Most of the sector gauges closed positive, except for the NSE Banking index which declined further by 0.19%. The NSE Insurance, NSE Oil/Gas, NSE Consumer Goods and the NSE Industrial indexes rose by 0.90%, 0.08%, 0.68% and 0.01% respectively. Meanwhile, market transactions remained weak as investors cherrypicked stocks. The volume and value of shares that exchanged hands today plunged by 19.24% and 16.17% to 0.13 billion units and N1.27 billion respectively. Elsewhere, NIBOR spiked for most tenor buckets tracked as financial system liquidity got tighter today. Also, NITTY increased for most maturities tracked on sustained sell-off. In the OTC bonds market, the values of FGN bonds increased for most maturities tracked. Also, the value of FGN Eurobond rose for all maturities tracked amid renewed positive sentiment.
