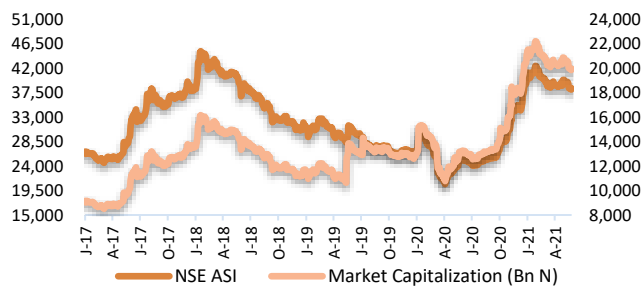


Nigerian Stock Exchange Index Falls by 0.25% as Bellwether Stocks Lose Grip; NIBOR Moderates for Most Maturities amid Financial Liquidity Boost ...

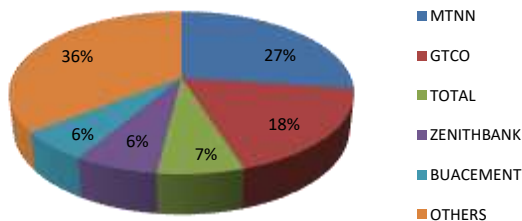
The domestic stock exchange All-Share Index (ASI) declined by 0.25% to 38,864.33 points as investors took profit on bellwether shares, especially GTCO, ZENITHBANK and BUACEMENT. The decline in ASI was despite the higher number of gainers (20) than losers (12) registered on the Exchange today. Hence, the year-to-date loss of the local bourse rose to 3.49%. Notably, capital gain on ACCESS shares lifted the NSE Banking index by 0.40%. Also, we saw bullish momentum in the consumer goods and oil & gas space. Hence, their respective indexes rose by 0.24% and 1.20% respectively. Meanwhile, market transactions came in weaker as volume and value of stock traded plunged by 77.99% and 73.44% to 0.14 billion units and N1.71 billion respectively. Elsewhere, NIBOR moderated for most tenor buckets tracked amid renewed financial system liquidity ease. However, NITTY moved southwards for most maturities tracked amid renewed bullish trend. In the OTC bonds market, the values of FGN bonds closed higher for most maturities tracked on renewed bullish activity. However, the value of FGN Eurobond moderated for most maturities tracked amid renewed bearish sentiment.
