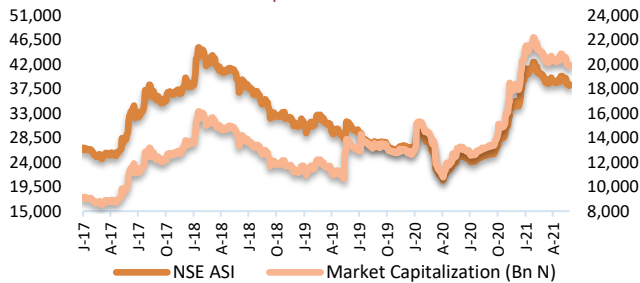


Local Bourse All-Share Index Revs by 38bps amid Sustained Bargain Hunting Activity; NITTY Moderates for All Maturities in line with NTB Auction Results Today...

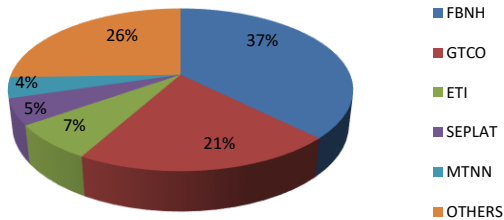
The domestic equities market index revved by 38 basis points (bps) to stay above 41,000 points level amid sustained investors' positive sentiment. We saw the number of gainers increased to 29 as against that of 27 it printed yesterday, hence lifting the year-to-date gain of the local bourse to 1.94%. Notably, OKOMUOIL, WAPCO, TRANSCOHOT and GTCO topped the gainers table even as all the sub-indices tracked closed northwards. Amid a robust sector-wide positive performance, the NSE Banking, NSE Insurance, NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices rose by 1.40%, 0.42%, 0.35%, 0.51% and 0.15% respectively. Nevertheless, market activity given the relatively smaller quantity of stocks that exchanged hands today at higher prices. Volume and value of stock traded moderated by 20.85% and 12.36% to 0.45 billion units and N4.47 billion respectively. Elsewhere, NIBOR fell for all tenor buckets tracked on sustained financial system liquidity boost while NITTY moved southwards for all maturities as investors traded along lower NTB rate, particularly for 364 day which trended lower to 7.25%. In the OTC bonds market, the values of FGN bonds traded remained flat for all maturities tracked. However, the value of FGN Eurobond increased for most maturities tracked on renewed buy interest.
