## Cowry Daily Market Insight 21 October 2021

Local Bourse Index Revs by 1.10% on High-cap Stocks; NIBOR Moves Southwards for Most Tenor Buckets on Sustained Liquidity Ease...

The domestic bourse index revved by 110 basis points (bps) to close at 41,704.11 points amid sustained bargain hunting activity, especially on shares of AIRTELAFRI, BUACEMENT, NB, NGXGROUP and MTNN as their respective share prices rose by 1.32%, 6.12%, 7.41%, 9.79% and 1.16%. Hence, the year-to-date gain of the local bourse rose to 3.56% even as the number of gainers increased to 23 as against that of the losers which stood at 19. Also, bullish performance was reflected across most sub-sectors as four of the five indexes tracked closed in green territory: the NSE Banking, NSE Insurance, NSE Consumer Goods and the NSE Industrial indices increased by 0.17%, 1.56%, 1.45% and 2.16% respectively. However, the NSE Oil/Gas indices moderated by 0.36%. Elsewhere, market activity weak given the volume and value of stocks which decreased by 56.72% and 33.43% to 0.22 billion units and N3.38 billion respectively. In the fixed income space, NIBOR fell for most tenor buckets tracked on sustained financial system liquidity ease. Also, NITTY fell for most maturities tracked on renewed bullish activity. In the OTC bonds market, the values of FGN bonds traded moved in mixed directions. However, the value of FGN Eurobond decreased for most maturities tracked on sustained bearish sentiments.
