



## Local Bourse Index Moderates by 0.15% amid Renewed Profit Taking Activity; NIBOR Stays Flat amid Quiet Money Market Activity...

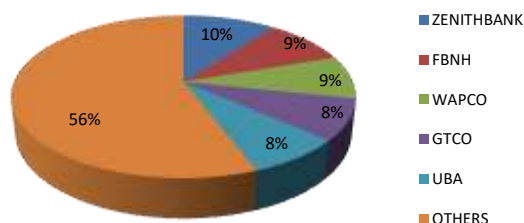
The domestic stock market All-Share Index (ASI) plummeted by 0.15% to close at 41,976.79 points amid renewed profit taking activity. Also, the Exchange printed a higher number of losers (32) than gainers (20) as investors booked profit following seven consecutive days of gains. Notably, investors booked profit on ETERNA, DANGSUGAR, NB, ETI and OANDO hence their respective share prices moderated by 9.94%, 2.94%, 0.94%, 4.49% and 7.92%. Consequently, the year-to-date gain of the local bourse fell to 4.24%. Bearish trend was also seen across sub-sectors tracked as the NSE Banking, NSE Consumer Goods and the NSE Oil/Gas indices moderated by 0.43%, 0.30% and 1.82% respectively. On the positive side, the NSE Insurance and the NSE Industrial indexes increased by 1.93 and 0.11% respectively. Elsewhere, market transactions decreased sharply as the volume and value of stocks traded mellowed by 66.53% and 76.46% to 0.38 billion units and N3.24 billion respectively. Meanwhile, NIBOR closed flat for all tenor buckets while NITTY moved in mixed directions across tenor buckets tracked. In the OTC bonds market, the values of FGN bonds traded rose for most maturities tracked. However, the value of FGN Eurobond fell further for all maturities tracked amid sustained sell pressure.
