



Local Bourse Maintains a Bearish Stance as Its All-Share Index Further Decline by 0.15%; NITTY Closes Higher for All Maturities Tracked amid Renewed Sell Pressure...

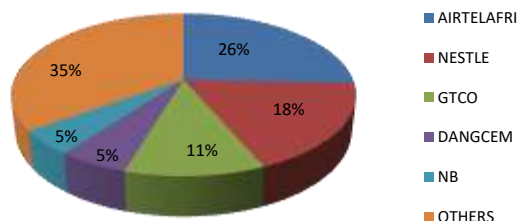
The Nigerian stock exchange index decreased by 0.15% to close at 43,285.97 points amid sustained profit taking activity even as short-term profit-takers' dominance was sustained today. Hence, the year-to-date gain of the local bourse fell to 7.49%. Also, the Exchange continued to print a higher number of losers (23) than gainers (12). Sell-offs were seen on tickers such as FBNH, UACN, WAPCO, NGXGROUP and AFRIPRUD, leading to a decrease in their respective share prices by 6.50%, 4.55%, 1.96%, 2.23% and 3.08%. Performance across sub-indices tracked was still weak as three out of five sub-indices tracked closed lower. The NSE Banking, NSE Oil/ Gas and the NSE Industrial indices plummeted by 0.19%, 0.19% and 0.12% respectively. However, the NSE Insurance and the NSE Consumer Goods indices rose by 0.59% and 0.14% respectively. Meanwhile market activity mellowed as the volume and value of stocks traded melted by 37.53% and 47.77% to 264.79 million and N6.08 billion respectively. Elsewhere, NIBOR fell for all tenor buckets amid renewed financial system liquidity boost. However, NITTY rose for all maturities tracked amid renewed sell pressure. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked. On the flip side, the value of FGN Eurobond fell for all maturities tracked amid sustained sell pressure.
