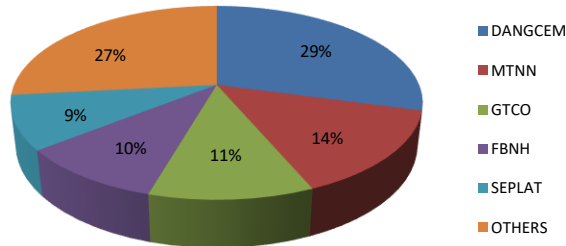


NGX All-Share Index Rises further by 0.10% amid sustained Buy Pressure; NIBOR stays flat across all Tenor Buckets...

The domestic stock market index rose by 0.10% to close at 42,394.71 points amid sustained bargain hunting activity even as we saw buying interest in tickers such as NEIMETH, UPDC, WEMABANK, GLAXOSMITH and COURTVILLE. Hence, their respective share prices rose by 9.82%, 9.43%, 5.26%, 4.20% and 2.78%. Consequently, the year-to-date gain of the local bourse rose to 5.27%. The Exchange printed a higher number of gainers (21) than losers (11) even as investors reshuffled their holdings to position in Blue-Chip stocks. Given the bullish sentiment, three of the five sub-sector gauges tracked closed in the green territory. The NGX Banking index, NGX Industrial Index and the NGX Consumer Goods index, increased by 0.29%, 0.31% and 0.03% respectively, while the NGX Insurance Index and the NGX Oil/Gas index fell by 0.48% and 0.41% respectively. However, market activity was weak today as the volume and the value of stocks traded today decreased by 58.39% to N142.17 million and 29.68% to N 2.49 billion respectively. Elsewhere, NIBOR was flattish for all tenor buckets. However, NITTY rose for most maturities tracked on demand pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for all maturities tracked. On the flip side, the values of FGN Eurobond moderated for all maturities tracked amid sustained bearish sentiment.
