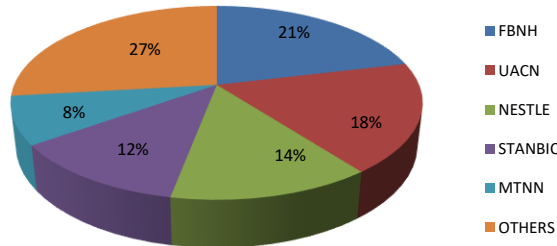


Local Bourse Index Falls Marginally by 0.01% amid Renewed Profit Taking Activity; NITTY Falls for Most Maturities Tracked amid Sustained Buy Pressure...

The Nigerian stock market All Share-Index fell marginally by 0.01% to close at 42,388.57 points amid renewed profit taking activity. We saw sell pressure in tickers such as ETERNA, MRS, UNITYBNK, GLAXOSMITH and OANDO. Hence, their respective share prices fell by 9.91%, 9.85%, 4.26%, 3.23% and 1.09%. Consequently, the year-to-date gain of the local bourse fell to 5.26%. The Exchange printed a higher number of gainers (21) than losers (15) despite the bearish sentiment. Elsewhere, three of the five sub-sector gauges tracked closed in the green territory. The NGX Insurance index, NGX Industrial Index and the NGX Consumer Goods index, increased by 1.17%, 0.02% and 0.05% respectively, while the NGX Banking Index and the NGX Oil/Gas index fell by 0.43% and 0.45% respectively. Elsewhere, market activity was strong as the volume and the value of stocks traded today increased by 94.08% and 58.29% to N275.93 million and N 3.94 billion respectively. Meanwhile, NIBOR moved in mixed directions. However, NITTY fell for most maturities tracked on sustained buy pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond moderated for most maturities tracked amid sustained bearish sentiment.
