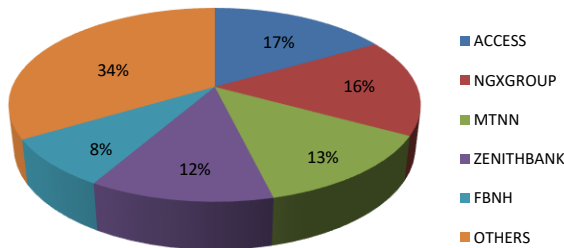


Nigerian Stock Market Index Rebounds Marginally by 0.01% amid Gains on CHIPLC, UNITYBNK, WAPIC, NEM Shares; NIBOR stays Flat across all Tenor Buckets...

The Local bourse Index rebounded marginally by 0.01% with a gain of 3.83% year-to-date to close at 41,813.27 points, even as the Exchange printed a higher number of Gainers (21) than Losers (12). CHIPLC (+10.00%), UNITYBNK (+8.33%), WAPIC (+8.16%) and NEM (+3.31%) closed positive while ROYALEX (-4.76%), ETI (-3.47%), ARDOVA (-2.99%) and DANSUGAR (-2.94%) closed negative. However, performance across sub-indices tracked were largely negative except for the NGX Banking Index and the NGX Insurance index which rose by 0.52% and 2.24% respectively. The NGX Consumer Goods index, NGX Oil/Gas Index and the NGX Industrial index, decreased by 0.27%, 0.78% and 0.06% respectively. Elsewhere, market activity was rather strong as the volume and the value of stocks traded today increased by 99.78% and 24.53% to 359.960 million shares and N 1.84 billion respectively. Elsewhere, NIBOR was flattish for all tenor buckets. However, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond rose for all maturities tracked amid sustained bullish sentiment.
