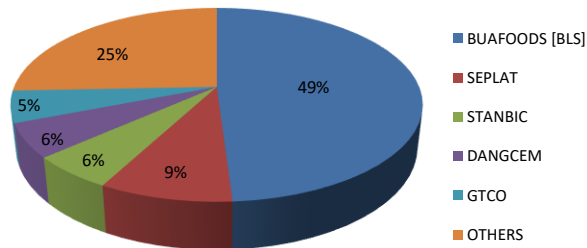


Local Bourse Index Falls by 0.09% amid Profit Taking Activities on Blue-Chip Stock; NIBOR Stays Flat across Most Tenor Buckets...

The domestic stock market plummeted by 0.09% to close at 43,859.30 points as the bears finally took over the Exchange. Hence the year-to-date gain of the local bourse fell to 2.68%. Also, the Exchange printed a higher number of losers (26) than gainers (17). Specifically, the share prices of MBENEFIT, BERGER, NESTLE, NB, UNILEVER and AIICO declined by 10.00%, 9.94%, 7.81%, 5.21%, 4.29% and 3.57% respectively. Meanwhile BUAFOODS Shares continued its dominance, as it further gained by 10.00% to lead the best five performing stocks. Given the bearish sentiment, performance across sub-indices tracked was largely negative, except for the NGX Banking Index and the NGX Oil/Gas index which rose by 0.16% and 0.95% respectively. The NGX Insurance Index, NGX Consumer Goods Index and the NGX Industrial Index fell by 2.14%, 4.76% and 0.27% respectively. Elsewhere, Market came in weak as the volume and the value of stocks traded decreased by 5.73% and 21.68% to 294.54 million shares and N 6.77 billion respectively. Meanwhile, NIBOR was flat across most tenor buckets tracked. However, NITTY rose for all maturities tracked amid renewed sell pressure. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid sustained bearish sentiment.
