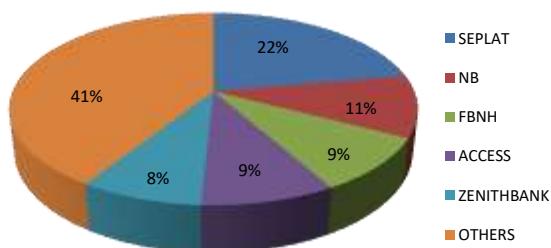

Local Bourse Index Rises by 0.15% amid Sustained Bullish Activity; NIBOR Moderates for Most Tenor Buckets on Financial System Liquidity Ease...

The Nigerian equities market All Share-Index rises by 0.15% to close at 44,608.82 points amid sustained bargain hunting activity. We saw buying interest in tickers such as COURTVILLE, SEPLAT, TRANSCORP, VITAFOAM, JAIZBANK, NB and GTCO, as their respective share prices increased by 9.52%, 4.86%, 4.85%, 4.51%, 2.56%, 1.48% and 1.18%. Consequently, the year-to-date gain of the local bourse rose to 7.59% even as the Exchange printed a higher number of gainers (20) than losers (14). Performance across sub-indices was positive except for the NGX Banking Index which fell by 0.11%. The NGX Insurance Index, NGX Consumer Goods Index and the NGX Oil/Gas index rose by 0.43%, 0.33% and 2.55% respectively. The NGX Industrial Index remained unchanged. Meanwhile, Market came in weak as the volume and the value of stocks traded decreased by 67.76% and 92.25% to 281.59 million shares and N 2.41 billion respectively. Elsewhere, NIBOR moderates for most tenor buckets on financial system liquidity ease. Also, NITTY fell for most maturities tracked on sustained buy pressure. In the OTC bonds market, the values of the FGN bonds remained flattish. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid sustained bullish sentiment.
