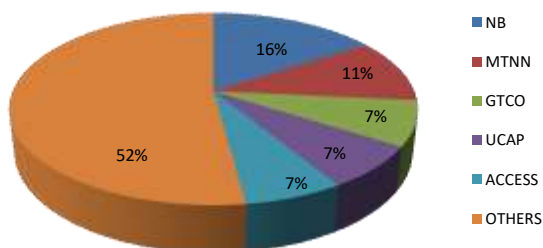


Local Bourse Index Rebounds by 0.08% amid Gains on UCAP, GUINNESS, TRANSCORP Shares; NITTY Falls for All Tenor Buckets on Buy Pressure...

The local bourse index rose by 0.08% to close at 47,102.48 points amid bargain hunting on shares of HONEYFLOUR, UCAP, GUINNESS, INTBREW and TRANSCORP. Hence, their respective share prices increased by 9.84%, 9.59%, 7.69%, 5.00% and 1.74%. Consequently, the year-to-date gain of the local bourse rose to 10.36% even as the Exchange printed a higher number of gainers (29) than losers (15). Performance across sub-indices was mixed bag as the NGX Banking Index and the NGX Consumer Goods Index rose by 0.08% and 1.05% respectively, however, the NGX Insurance Index and the NGX Oil/ Gas Index fell by 0.79% and 3.42% respectively. The NGX Industrial Index remained unchanged. Meanwhile, market activity was strong today as the volume of stock traded rose by 18.71% to 424.70 million even as the value of stocks traded increased by 0.64% to N6.52 billion. Elsewhere, NIBOR rose for most maturities tracked on financial system liquidity squeeze. However, NITTY fell for all tenor buckets tracked on buy pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for all maturities tracked. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked amid sustained sell pressure.
