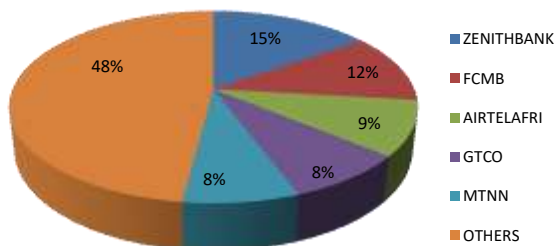

Local Bourse Index Revs by 0.14% amid Sustained Bargain Hunting Activity; NIBOR Moves Northward on Financial Liquidity Squeeze...

The domestic equities market Index rose by 0.14% to close at 47,394.53 points, even as the Exchange printed a higher number of gainers (23) than losers (15). Specifically, the insurance shares topped the gainers table today – LINKASSURE (+10.00%), ROYALEX (+9.60%), REGALINS (7.69%), SUNUASSUR (+7.69%) and NIGERINS (+7.14%). On the flip side, we saw profit taking on the shares of ACADEMY (-9.69%), RTBRISCOE (-9.57%), JAIZBANK (-5.19%), VITAFOAM (-4.90%) and AFRIPRUD (-4.76%). Performance across sub-indices was relatively positive as the NGX Banking Index, the NGX Consumer Goods Index, the NGX Insurance Index and the NGX Industrial Index rose by 0.55%, 0.99%, 0.29% and 0.18% respectively. However, the NGX Oil/ Gas index moderated by 0.21%. Meanwhile, market activity was largely positive today as the volume and value of stock traded increased by 18.73% and 0.61% to 300.76 million and N2.77 billion. Elsewhere, NIBOR rose for most tenor buckets on financial system liquidity strain. However, NITTY fell for all maturities tracked amid buy pressure. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid renewed sell pressure.
