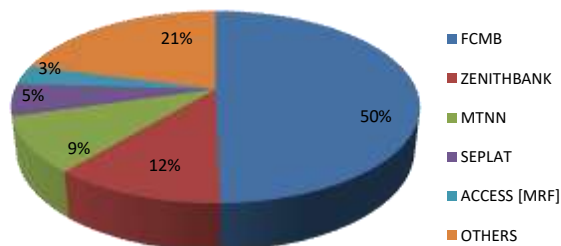

Domestic Bourse All-Share Index Gains 0.16% as RTBRISCOE & UACN Shares Remain Investors Toast; NIBOR Rises for all Tenor Buckets on Renewed Liquidity Strain...

The NGX All-Share index gained 0.16% to close at 47,437.48 points, recording three consecutive days of buy pressure. Notably Tickers such as BTBRISCOE and UACN remained investors toast today as their respective share prices rose by 8.96% and 5.97% respectively. NIGERINS gained 10.00%, UPDC (7.61%) and CORNERST (5.71%) to stay amongst the top five gainers. Notably, the year-to-date gain of the index breached 11.00% level upward despite the Exchange printing an equal number of gainers (22) than losers (22). The sustained bullish market sentiment was not really felt at the sub-sector level as indices moved in mixed directions. The NGX Banking and the NGX Insurance indices rose by 0.34% and 0.28% respectively. However, the NGX Oil/Gas index fell by 0.35% while the NGX Consumer Goods and the NGX Industrial indices closed flat. Meanwhile, market activity was largely positive as the volume and value of stocks traded rose by 341.02% and 56.97% to 1.15 billion and 7.03 billion respectively. Elsewhere, NIBOR rose for all tenor buckets on renewed financial liquidity strain. NITTY fell for most maturities tracked on buy pressure. In the OTC bonds market, the values of the FGN bonds remained largely flattish for most maturities tracked. However, the values of FGN Eurobond moderated for all maturities tracked as yields rose for most maturities tracked.
