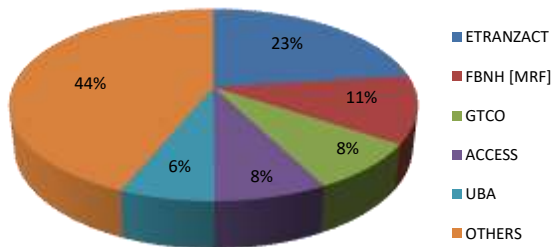

NGX All-Share Index Moderates Further by 0.15% as Investors Continue to Take Profits; NIBOR Moves in Mixed Directions across Tenor Buckets...

The domestic stock market All-Share index declined further by 0.15% to close at 47,282.67 points as investors take profits on shares of MRS (9.96%), IKEJAHOTEL (9.87%), WAPIC (9.43%), MBENEFIT (7.41%) and ACCESS (5.77%). Hence, the year-to-date gain of the index decreased to 10.69% even as the Exchange printed a higher number of losers (20) than gainers (13). Amid sustained bearish mood in the equities market, most of the sub-sector indices closed red, especially the NGX Banking index which decreased by 0.63%. Also, the NGX Insurance index, NGX Oil/Gas index and the NGX Industrial index fell by 0.48%, 0.23% and 0.01% respectively. On a positive note, the NGX Consumer Goods index rose by 0.07% as the share price of PZ rose by 9.55%. Meanwhile, market activity went in mixed directions as the volume of stocks traded rose by 150.07% to 599.51 million while the value of stocks traded fell by 1.56% to N3.83 billion. Elsewhere, NIBOR moved in mixed directions across tenor buckets tracked. However, NITTY moderated for most maturities tracked on sustained buy pressure. In the OTC bonds market, the values of the FGN bonds were flattish across maturities tracked. On the positive side, the values of FGN Eurobond price increased for most maturities tracked.
