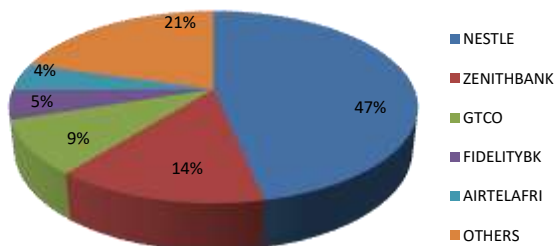

Local Bourse All-Share Index Rebounds by 1bps amid Renewed Bargain Hunting Activity; NIBOR Rises for Most Tenor Buckets on Renewed Liquidity Strain...

The NGX All-Share index rebounded by 0.01% to close at 46,964.23 points amid renewed bargain hunting activity despite the Exchange printing a lower number of gainers (15) than losers (16). Specifically, we saw bullish sentiment on Symbols such as PZ (6.90%), JAPAUFGOLD (6.45%), FTNCOCOA (6.06%), AFRIPRUD (5.98%) and CHIPLC (5.00%). Hence, the year-to-date gain of the index rose slightly to 9.94%. On the weak side, NNFM share price fell by 7.83%, followed by FCMB (7.22%), LIVESTOCK (6.06%) and NEIMETH (3.68%). Notably, performance across sub-sector was relatively positive as the NGX Banking index, NGX Insurance index and the NGX Consumer Goods index rose by 0.48%, 0.15% and 0.07% respectively. However, the NGX Oil/Gas index and the NGX Industrial index were flat. Meanwhile, market activity was mixed as the value of stocks traded increased by 59.21% to N4.18 billion. However, the volume of stock traded moderated by 17.52% to 177.09 million units. Elsewhere, NIBOR rose for most tenor buckets tracked amid renewed liquidity squeeze. However, NITTY decreased for all maturities tracked amid renewed buy interest. In the OTC bonds market, the values of the FGN bonds was flattish for most maturities tracked. The values of FGN Eurobond increased for most maturities tracked on renewed demand pressure.
