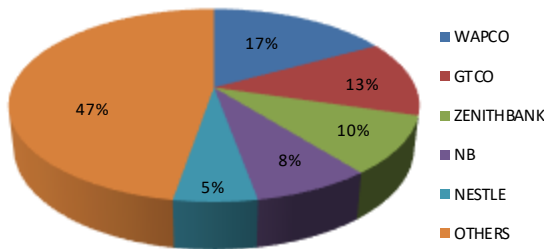

NGX All-Share Index Rises Marginally by 1bps amid Sustained Bargain Hunting Activity; NIBOR Stays Flat across all Tenor Buckets Tracked.....

The local bourse All-Share index rose marginally by 0.01% to close at 48,571.75 points amid sustained bargain hunting activity despite the Exchange printing a lower number of gainers (18) than losers (23). Specifically, we saw bullish sentiment on Symbols such as ACADEMY (+9.92%), CADBURY (+9.09%), PRESCO (+8.98%), GUINNESS (+7.54%) and DANGSUGAR (3.13%). Hence, the year-to-date gain of the index rose slightly to 13.71%. On the weak side, IKEJAHOTEL share price fell by 9.68%, followed by LIVESTOCK (-9.50%), ETRENA (-4.68%) and OANDO (-4.00%). Performance across sub-indices were relatively negative, as the NGX Banking Index, NGX Insurance Index and the NGX Oil/ Gas fell by 1.46%, 0.85% and 0.72% respectively. However, the NGX Consumer Goods Index and the NGX Industrial Index rose by 0.68% and 0.37%. Meanwhile, the total volume of stock traded decreased to 246.70 million units from 464.73 million units. Also, the value of stock traded fell to N2.32 billion from N7.01 billion in the prior trading session. Elsewhere, NIBOR was flattish for all tenor buckets tracked. Meanwhile, NITTY rose for most maturities tracked on sell pressure. In the OTC bonds market, the values of the FGN bonds rose for most maturities tracked amid renewed buy pressure. The values of FGN Eurobond depreciated for all maturities tracked on sustained sell-off.
