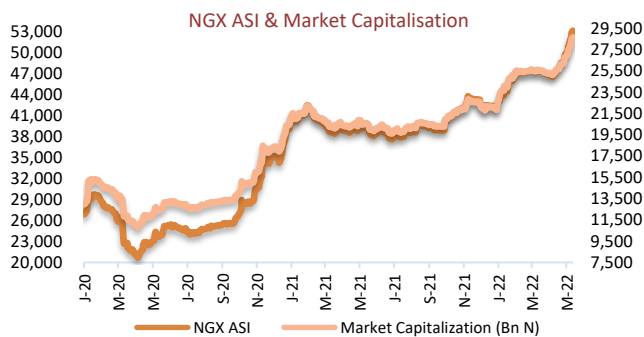
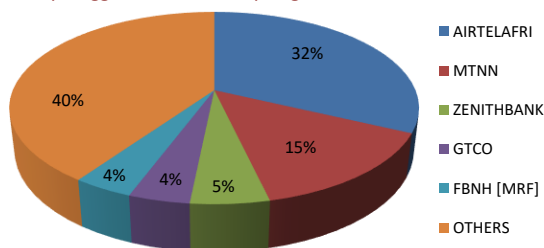


Local Bourse ends the Week in Negative Territory as ASI Falls by 0.55% on Weak Investor's Demand. NIBOR Falls for Most Tenor Buckets on Liquidity ease...

The local bourse closed the week in negative territory as All-Share Index moderated by 0.55% to 52,979.96 points, dropping from its previous close of 53,275.49 point. Hence, the year-to-date performance of the index decreased to 24.03%. Despite the bearish sentiment in the market today, the Exchange printed a higher number of gainers (28) than losers (25). Specifically, the share prices of tickers such as MTNN, CHIPLC, CUSTODIAN, CAVERTON and PZ plunged by 7.78%, 7.69%, 6.67%, 5.00%, and 4.06% respectively amid sell pressure. Performance across sub-sector gauges was relatively strong as the NGX Banking index, NGX Insurance index, NGX Consumer Goods index, NGX Oil/Gas index and the NGX Industrial index rose by 0.04%, 1.95%, 0.12%, 0.62% and 0.03% respectively. Meanwhile, market activity was mixed today as the volume of stock traded increased by 59.01% to 436.58 million units; while, the value of stocks traded plummeted by 61.85% to ₦3.22 billion. Elsewhere, NIBOR fell for most tenor buckets on renewed financial system liquidity ease. Meanwhile, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked on buy pressure.
