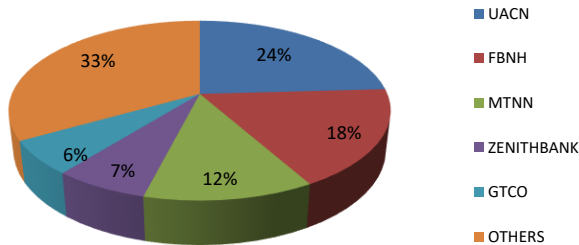


## Local Bourse Index Rebounds by 0.18% amid Renewed Bargain Hunting Activity; NIBOR Stays Flat across all Tenor Buckets Tracked...

The domestic equities market Index rose by 0.18% to close at 52,908.24 points, even as the Exchange printed a higher number of gainers (22) than losers (16). Specifically, the Consumer Goods and Insurance shares topped the gainers table today – NEM (+9.95%), CHAMPION (+8.06%), NB (7.06%), HONEYFLOUR (+4.76%) On the flip side, we saw profit taking on the shares of WAPIC (-4.35%), UACN (-4.35%), INTBREW (-3.33%), DANGSUGAR (-3.03%) and FBNH (-0.90%). Performance across sub-indices was relatively positive as the NGX Banking Index, NGX Consumer Goods Index, NGX Insurance Index and the NGX Oil/ Gas Index rose by 0.95%, 1.41%, 1.05% and 0.53% respectively. However, the NGX Industrial index moderated by 0.01% Elsewhere, Market activity was mixed today, as the volume of stocks traded today rose by 3.11% to 282.97 million units; While, the value of stocks traded decreased by 16.30% to ₦3.37 billion. Meanwhile, NIBOR was flattish for all tenor buckets tracked. However, NITTY fell for most maturities tracked on renewed buy pressure. In the OTC bonds market, the values of the FGN bonds moved in mixed directions. On the flip side, the values of FGN Eurobond remained unchanged for most maturities tracked.
