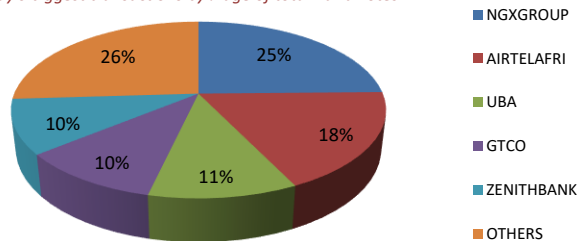


Local Bourse Moderates by 0.14% as Investors Book Profits; NIBOR Falls for most Tenor Buckets Tracked amid Sustained Liquidity Ease...

Bearish Sentiment overshadowed the bullish run from yesterday as the NGX All share Index fell by 0.14% to close at 53,193.98 points. Hence, the year-to-date performance of the index decreased to 24.53%, even as the Exchange printed a higher number of losers (20) than gainers (16). Specifically, the share prices of tickers such as CHAMPION, NEM, FBNH, CHAMS and ACCESSCORP fell by 9.79%, 3.86%, 5.50%, 4.00%, and 1.51% respectively amid profit taking activities. Performance across sub-indices tracked was mixed bag as the NGX Banking index and the NGX Insurance index fell by 0.86% and 1.76% respectively, while the NGX Consumer Goods index and the NGX Industrial index rose by 0.13% and 0.03% respectively. The NGX Oil/Gas index remained unchanged. Elsewhere, Market activity was mixed bag, as the volume of stocks traded today slightly rose by 6.11% to 248.96 million units; While, the value of stocks traded decreased by 32.19% to N1.86 billion. Meanwhile, NIBOR fell for most maturities tracked amid sustained financial system liquidity ease. Also, NITTY fell for all maturities tracked amid renewed sell pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid sustained sell pressure.
