


Cowry Daily Market Insight 16 June 2022

Stock Market Sheds N196.4 billion in Capitalization, as Profit-Taking Continues; NIBOR Rises for Most Tenor Buckets Tracked on Liquidity Squeeze...

The domestic stock market All-Share index declined further by 0.69% to close at 52,411.09 points as investors took profits on shares of CONOIL (-10.00%), BUAFOODS (-9.97%), ETRENA (-6.25%), WAPIC (-2.26%), ZENITHBANK (-1.19%) and AIRTELAFRI (-0.94%). Hence, the year-to-date gain of the index decreased to 22.70% even as the Exchange printed a higher number of losers (22) than gainers (12). Amid sustained bearish mood in the equities market, most of the sub-sector indices closed red, especially the NGX Oil/Gas index which decreased by 0.63%. Also, the NGX Banking index, NGX Insurance index and the NGX Industrial index fell by 0.62%, 0.28% and 0.01% respectively. The NGX Consumer Goods index was the only exemption as it marginally rose by 0.01%. Elsewhere, Market activity was rather strong today, as the volume of stocks traded rose by 12.51% to 211.61 million units; Also, the value of stocks traded increased by 0.09% to N2.37 billion. Meanwhile, NIBOR rose for most maturities tracked amid sustained financial system liquidity strain. Similarly, NITTY rose for all maturities tracked amid sustained sell pressure. In the OTC bonds market, the values of the FGN bonds rose for most maturities tracked amid bullish sentiment. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked on sell pressure.
