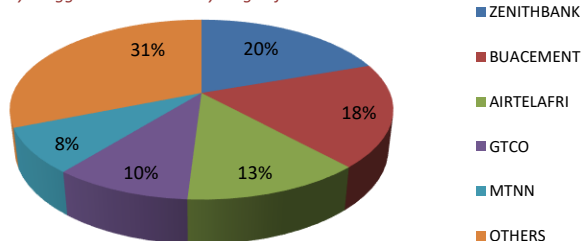


Investors' Bearish Sentiment Persists, Rounding Up the Week by a Decline of 1.21%; NIBOR Rises for Most Tenor Buckets Tracked amid sustained Liquidity Strain...

Equities trading at the Nigerian Exchange Limited (NGX) closed bearish (-1.21%), extending the negative trend as a majority of Tier-1 bank shares put up for sale failed to find buyers. Accordingly, the year-to-date performance of the index decreased to 21.21%, even as the Exchange printed a higher number of losers (24) than gainers (10). ELLAHLAKES topped gainers growing by 8.40% while MCNICHOLS led the laggards chart declining by 9.76%. Specifically, Big lenders ETI (-5.64%), FBNH (-3.90%), ZENITHBANK (-2.09), GTCO (-2.08%), UNITYBNK (-1.75%) and UBA (-0.64%) led the slide among banking stocks. Amid sustained bearish mood in the equities market, all five of the sub-sector indices tracked closed red, especially the NGX Banking index which decreased by 2.31%. Also, the NGX Insurance index, NGX Consumer Goods index, NGX Oil/Gas index and the NGX Industrial index fell by 0.24%, 0.64%, 0.58% and 0.01% respectively. Elsewhere, Market activity was rather strong today, as the volume of stocks traded rose by 13.98% to 241.19 million units; Also, the value of stocks traded increased by 54.96% to N3.67 billion. Meanwhile, NIBOR rose for most maturities tracked amid sustained financial system liquidity squeeze. However, NITTY fell for all maturities tracked amid renewed buy pressure. In the OTC bonds market, the values of the FGN bonds moved in mixed directions. On the flip side, the values of FGN Eurobond appreciated for most maturities tracked amid bullish sentiment.
