

Gain in PRESCO, FBNH, DANGCEM and Others Lift NGX-ASI by 0.56%; NITTY Rises for All Tenor Buckets amid Sustained Sell Pressure...

The domestic equities market Index rose by 0.56% to close at 51,377.21 points, even as the Exchange printed a higher number of gainers (18) than losers (16). Hence, the year-to-date gain of the NGX ASI rose to 20.28%. Specifically, shares of ELLAHLAKES (+10.00%), PRESCO (+9.71%), FBNH (+9.52%), BUAFOODS (+6.87%) FLOURMILL (+2.81%) WAPCO (+1.89%) and DANGCEM (+1.85%) inched upward. On the flip side, we saw profit taking on the shares of NNFM (-9.91%), ETI (-5.94%), BUACEMENT (-3.16%), UCAP (-1.96%) and OANDO (-1.38%). Despite the sustained bullish sentiment, Performance across sub-sector gauges was largely negative except for the NGX Consumer Goods index which rose by 0.14%. The NGX Banking index, NGX Insurance index, NGX Oil/Gas index and the NGX Industrial index fell by 0.61%, 0.39%, 0.19% and 0.28% respectively. Elsewhere, Market activity was strong today, as the volume of stocks traded rose by 37.37% to 229.37 million units; Similarly, the value of stocks traded increased by 16.68% to N3.20 billion. Meanwhile, NIBOR moved in mixed directions. However, NITTY rose for all maturities tracked on sustained sell pressure. In the OTC bonds market, the values of the FGN bonds gained for most maturities tracked amid sustained bullish sentiment. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked amid renewed sell pressure.
